# **Entity tax residency self-certification form –INSTRUCTIONS**

# Please read these instructions before completing the form.

填寫表格前,請先參閱下列指引。

Regulations based on the OECD Common Reporting Standard ("CRS")" require *Bank SinoPac Hong Kong Branch* to collect and report certain information about an account holder's tax residency. If the account holder's tax residence is located outside Hong Kong, we may be legally obliged to pass on the information in this form and other financial information with respect to your financial accounts to Hong Kong Inland Revenue Department and they may exchange this information with tax authorities of another jurisdiction or jurisdictions pursuant to intergovernmental agreements to exchange financial account information.

根據採用經濟合作與發展組織(以下簡稱OECD)共同申報準則(以下簡稱CRS)的規定,要求永豐商業銀行股份有限公司香港分行(以下簡稱本行)收集並匯報帳戶持有人的稅務居留地。如帳戶持有人之稅務居留地為香港以外國家,本行將依法匯報本表所載資訊及貴戶之財務帳戶資料給香港稅務局。香港稅務局將依與各稅務管轄區所簽訂的協議交換財務帳戶資訊。

This form will remain valid unless there is a change in circumstances relating to information, such as the account holder's tax status or other mandatory field information that makes this form incorrect or incomplete. In that case you must notify us and provide an updated self-certification.
