Section 5 帳戶授權書 Account Mandate

(A) 吾等(會議主席及一名董事/秘書*)代表 _____
(「本公司」)要求及授權永豐商業銀行股份有限公司(成立於台灣的股份有限公司)(「貴行」)根據下文(B)所列決議案，開立、維持若干採用本公司名義賬戶及提供銀行服務予本公司。

(B) 本人證明於 _____ 年 _____ 月 _____ 日在 _____
所適當並妥為召開及舉行的本公司董事會議上(該會議由始至終具有有效法定人數出席及行事)，下列各決議案已獲通過，現正具十足效力及作用：

1. 本公司聘用貴行提供服務並委任貴行為本公司的銀行，受限於貴行的賬戶一般條款及條件(「條款」)及不時生效以管限賬戶及銀行服務之操作及運作的有關規則。本公司已接獲該條款及有關規則的文本並同意受其約束。
2. 本公司在貴行開立及持續一個或多個採用本公司名義賬戶。
3. 本申請書所提述的各有關人士(每位以下稱為「獲授權代表」)均獲授權代表本公司(如按照本申請書中所訂的獲授權簽署安排(「獲授權簽署安排」)行事時)隨時在認為適當的情況下安排在貴行開立任何性質及以貨幣計值的其他採用本公司名義賬戶及安排貴行向本公司提供其他銀行服務。
4. 指示貴行：
 - (a) 兌現及遵照代表本公司所開出的所有支票、票據及其他付款指令以及代表本公司所承兌的所有匯票(不論本公司有關的(各)賬戶是否有存款或被透支)，遵照為任何賬戶或與此有關而代表本公司所發出的所有指示，以及就本公司在貴行的任何賬戶，接受所有收據作為有效解除貴行於任何時間對所存入的或貴行所欠的任何款項之責任，惟該等支票、票據、付款指令、匯票、指示或收據均須已由獲授權代表根據獲授權簽署安排代表本公司簽署；
 - (b) 代收或收取應付予本公司的任何支票、付款指令、票據、利息或股息，並將有關的所得款項存入本公司有關的(各)賬戶，即使：
 - (i) 該支票、付款指令或票據並未經其收款人妥為背書；或
 - (ii) 該支票、付款指令或票據的法定所有權有未確定之處，例如因該支票、付款指令或票據屬須付予本公司(但並非以本公司的法團名稱所能識別，而是以本公司的註冊生意名稱或某些其他名稱所識別)，而在所有情況下，不論該支票、付款指令或票據是否附有劃線限制其可轉讓性，本公司對於貴行在代表本公司處理該支票、付款指令或票據時可能產生的所有法律責任，應使貴行免遭損失並確保貴行獲得賠償；
 - (c) 接納關於出具任何信用證、擔保、彌償保證或反彌償保證的任何申請或要求並按此行事或接納有關任何信用證、擔保、彌償保證或反彌償保證的任何指示並按此行事，以及按照有關本公司與貴行的任何其他交易或有關本公司在貴行的任何賬戶的任何指示行事，但該等申請、要求或指示須已由獲授權代表根據獲授權簽署安排代表本公司簽署；
 - (d) 兌現及遵照從本公司在貴行的任何賬戶提取任何或所有款項的任何付款指令，及遵照指示以交付、處置或處理貴行為本公司或為本公司的賬戶以安全保管、擔保或其他形式在任何時間所持有的任何證券、契據、文件或其他財產，但該等付款指令或指示須已由獲授權代表根據獲授權簽署安排代表本公司簽署；
 - (e) 以下列各項作為依據並按其行事：
 - (i) 不時由任何獲授權代表發出或看來是由其發出的任何電話指示；
 - (ii) 不時發給或看來是發給貴行的任何電話圖文傳真(「電話傳真」)指示，如該指示已由獲授權代表根據獲授權簽署安排代表本公司簽署；及/或
 - (iii) 不時由任何獲授權代表發出或看來是由其發出的任何其他指示；

但貴行本身不須查詢有關發出或看來發出該等指示的(各)人士的授權或身分，惟該等指示亦須根據條款、貴行的普通商業協議及/或本授權書而發出。本授權書第4段所載的授權不得損害貴行對下列各項的拒絕權利：(i)因本公司對貴行的實際或是或然負債或貴行可能獲悉任何第三方對有關擔保、契據、文件或財產的權益而拒絕承兌及遵照該等支票、票據、付款指令、匯票、指令、收據、申請、要求或指示及(ii)拒絕執行以電話或電話傳真通訊所發出的任何指示或所作出的任何要約。此外，如根據任何司法管轄區的法律，從記在本公司各賬戶貸項之下的任何款項向本公司作出任何付款或解除本公司給予貴行或存放於貴行的任何擔保或財產(不論是作為擔保或其他性質)會屬違法，則本公司承認、確認及同意貴行將無任何責任作出任何上述付款或解除。

5. 獲授權代表如按獲授權簽署安排行事，均獲授權代表本公司：

- (a) 與貴行安排不時以信貸、貼現、透支、貸款、按揭或以其他方式放款予本公司及由貴行出具擔保書，並且代表本公司簽署與此有關的任何文件，為此而提供的任何按揭、質押或其他擔保，以及任何承諾、反彌償保證或貴行所規定的其他文件，只要以上各項均無須以本公司的法團印章簽立；
- (b) 提取及處置本公司不論為了安全保管或其他原因而可能存放於貴行的任何證券、貴重物品或其他財產；及
- (c) 與貴行訂立買入及/或出售即期或遠期外匯合約，及：
 - (i) 向貴行簽立及交付證明該等合約的文件；
 - (ii) 簽立該等合約的續訂或續期文件；或
 - (iii) 存放保證金或其他擔保於貴行及按貴行所要求，簽立與此有關的文件，作為該等合約的擔保。

為本公司「帳戶資料約定人」並獲授權代表公司共同或個別地做任何及簽署有關以本公司名義開立的所有或任何現有帳戶日後之所有帳戶資料異動或獲授權簽署安排異動等必需文件(包括但不限於簽署《公司帳戶資料異動申請書》)及事情。以上任一帳戶資料約定人與更改任何帳戶資料有關而所做的任何行為或事情，以及簽署的文件均有本公司有效授權，並對本公司具有約束力。

7. 貴行可隨時(即使有任何賬目的結算或其他任何事情)，將當時以本公司名義開立的所有或任何現有賬戶合併或綜合(不論屬存款、貸款或任何其他性質，並且不論是否須給予通知)，並將不論處於任何地方的任何一個或以上的該等賬戶中記於貸項之任何款項抵銷或轉撥，用以清償本公司在任何其他賬戶或在任何其他方面對貴行的任何負債，不論該等負債是現在或將來的、屬實際或或然的、基本或附屬的以及各別或共同的，而若該合併、抵銷或轉撥須將一種貨幣兌換成另一種貨幣，則該項兌換應按合併、抵銷或轉撥當日由貴行決定為有關的外匯市場的即期匯率(由貴行作不可推翻之釐定，其詳情應按本公司的要求而提供)計算。

9. 按獲授權簽署安排行事的獲授權代表均獲授權代表本公司為了操作本公司在貴行可能持有或開立的任何賬戶及為了貴行向本公司所提供或將會提供的任何其他銀行服務而同意貴行不時訂明的規則。

10. 貴行獲授權向其他人士、公司、機構及團體取得貴行可能認為適當的有關本公司的資料(包括查詢其他財務機構)及向其他信貸提供者、信貸局、財務機構、本公司的會計師、政府(包括所有海外政府及其部門及半政府機構)、具司法管轄權的法院及仲裁庭(包括海外國家的法院及仲裁庭)提供有關本公司的賬戶及本公司與貴行或透過貴行進行的買賣及交易的詳情。

11. 在沒有相反指示的情況下，其後以任何貨幣開立的任何賬戶及其後申請及由貴行提供的任何銀行服務，只要在上文所列出的條款可適用的範圍內，均須根據該等條款操作及處理。

12. 將本公司的法團註冊證書及更改名稱法團註冊證書(如有)、商業登記證書以及組織章程大綱及章程細則(或如適用時，同等的組織或其他文件)的最新經核證文本立即提供予貴行以及在每次修訂的決議案獲通過後盡快將其經核證文本提供予貴行。

13. 將董事及獲授權代表本公司簽署的任何其他人士的姓名及簽字式樣的名單提供予貴行。為免生疑問，各獲授權代表均獲授權代表本公司(如根據獲授權簽署安排行事時)簽署所有支票及票據以及作出本授權書所提述的行為。對於經由或看來是由獲授權代表使用本申請書中其姓名旁邊顯示式樣的形式所簽署的指示，貴行有權以此作為依據並且如按此行事時獲全面保障。

14. 董事的任何決議案的文本(如看來是由會議主席核證為正確的話)就貴行與本公司之間而言，屬通過該決議案的不可推翻的證據。

- (b) 更改本公司的組織章程大綱及章程細則(或同等的組織文件)；
